

Applicant seeks to shift the percentage of maximum allowed Site Coverage in the Bulk Regulations and Data Table. To account for this increase, the maximum allowed Site Coverage in Subarea E will decrease from 40% to 34.6%. The overall site coverage for Institutional Planned Development No. 43 will remain at 35%.
